The Marijuana Establishment RFI Evaluation and Scoring sheet is completed independently by each Select Board member. **All initial RFI Respondents will be evaluated on the same matters.** Scoring is based on levels of strength of adherence to the stated criteria, ranked 1-5, with 5 being the strongest, and 1 being the weakest. The members shall submit a copy of their evaluation to the Chief Administrative Officer to compile the scoring results.

Scoring: Each numbered evaluation topic shall be tallied by adding the value given by each Select Board member for that topic, and dividing the sum by three (3), the number of Select Board members for the average score per topic. The sum of all topics will be aggregated and the average scores compared to the score ranges.
